Documents Required for Registration

ARTICLE 19- The following documents are required for the registration:

- (1) High School (Secondary Education) Diploma: The original of the high school (secondary education) diploma and its Turkish translation issued by the Embassy, Consulate, or Notary.
- (2) Diploma Equivalency Certificate: It is a document obtained from T.R. Ministry of National Education or T. R Embassy or Consulates in their countries and shows that the High School Diploma is equivalent to the diplomas obtained from the Turkish High Schools.
- (3) Exam Result Document: The original of the exam result document and/or Turkish translation approved by T.R Embassy, Consulate or Notary (SAT, ACT, YÖS, etc.) used for application and containing the verification code.
- (4) Candidates who apply and are placed with the results of the international exam will be required to confirm their user names and passwords and their exam results during registration. The registrations of the candidates who cannot provide this will be cancelled.
- (5) Passport: Copy of passport showing the nationality of the international student and valid for at least 6 months, which is issued by the Embassy, Consulate, or Notary. (In case the passport is not in Turkish or English, Turkish or English translation approved by Embassies, Consulates, Notary or Sworn Translator must be submitted.)

(Dual citizenship holders one of which is Turkish and preferring that one who have completed their entire high school education abroad (excluding TRNC high schools) must submit a copy of the pages of their passport or a certified copy taken from the general directorate of security showing the entrance- exit dates considering the education date they have had.)

- (6) A copy of the Internationally Valid Foreign Language proficiency Certificate of Compliance issued by the Turkish embassy or representative in their own country.
- (7) 4 photos, $50 \text{ mm} \times 60 \text{ mm}$ in size, on a white background and without a pattern, and must have been taken within the last six months. (The photo-copy version of the photo is inadmissible.)

- (8) Certified Transcript: The original document stating the average grades of graduation and the subjects taken must be issued by the high school the candidate attended. The original Turkish translation of the transcript issued by the Turkish Embassy, consulates, or notary must be submitted for the applicants residing abroad.
- (9) A copy of the Blue Card: Blue card-holders submit a copy of it evidencing their present status.
- (10) Certificate of Identity register copy: Certificate of identity register copy that shows the status of the dual citizenship holders who have later acquired Turkish citizenship to certify their present state.
- (11) TÖMER Certificate (if any): A document showing that the applicant has a score at the level of "C1" according to the "Common European Framework of Reference for Languages" from the Turkish Language Application and Research Center (TÖMER).
- (12) Financial Status Document: It is a document showing that the student can afford the basic living expenses. All expenses (accommodation, food, educational materials and personal expenses) to be covered during the education period fall under the responsibility of students. (Document to be issued by the person / institution / organizations that are supposed to sponsor the student for his/ her expenses)
- (13) Photocopy of the protection cards of the students who are accepted with an international temporary protection card.
